All of the fund's expenses are charged to capital. This has had the effect of increasing the distributions paid on an annualised basis by approximately 0.90 percentage points on the B share class and reducing the capital performance by an equivalent amount.

Fund manager's commentary

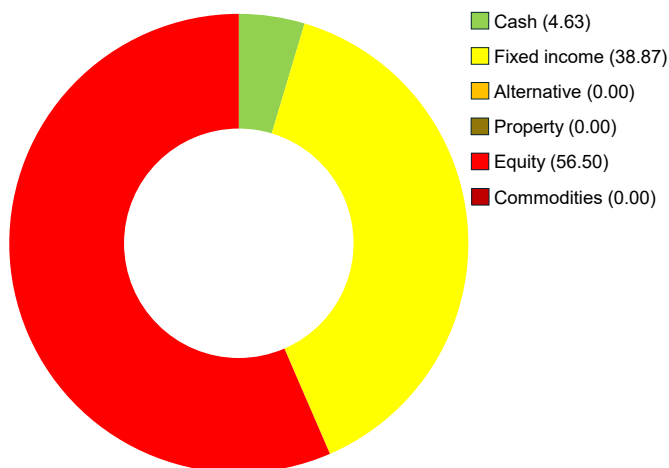
Global bonds and equities fell 1.90% and 1.28% respectively in sterling as oil prices rose 20.97% in response to renewed Middle East conflict, triggering fears that interest rates will rise to combat resurgent inflation. US stocks fell 1.44% in sterling but the EF Brompton Global Income Fund's Xtrackers S&P 500 Equal Weight exchange-traded fund (ETF) holding fell only 0.41% because of its low technology weighting during a month in which global technology stocks fell 5.77% on concerns that artificial intelligence datacentres may fail to deliver economic returns. Some hardware suppliers were caught in the sell-off and the iShares MSCI Global Semiconductors ETF fell 21.89%. Equities in Asia excluding Japan and emerging markets also underperformed, down 4.51% and 4.36% respectively in sterling. The portfolio's holdings outperformed, however, with Prusik Asian Equity Income Subcontinent, which has a bias towards consumer-oriented stocks, was added. UK stocks also outperformed, up 3.86%, and smaller companies did better, up 5.79%. Within the portfolio, Man Income did best, rising 4.21% because of its bias towards small and medium-sized smaller companies. Within the bond allocation, the sterling-hedged Pimco Global Low Duration Real Return holding gained 0.10% but the iShares \$ Treasury Bond 7-10 Years ETF fell 3.12%, driven lower by the dollar's 1.37% fall against sterling. The EF Brompton Global Income Fund fell 0.34% in July while the sector fell 0.40%. At 31 July, the historic yield was 3.13%.

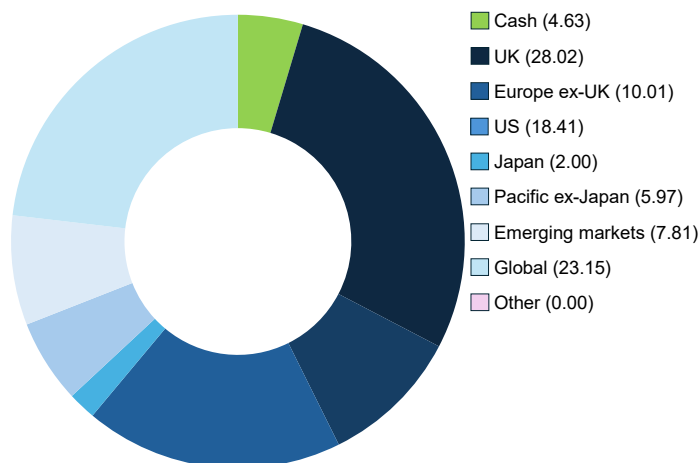

Investment policy

The Fund will typically invest a minimum of 80% of its net asset value in collective investment schemes, exchange traded funds and unregulated collective investment schemes.

The Fund may also invest in investment trusts (and similar instruments), other transferable securities, money-market instruments, fixed income instruments, deposits and foreign exchange contracts.

It is expected that exposure to equity markets will typically range from a minimum of 20% to a maximum of 60% of the total Fund, with the aim of achieving the Fund's objective. However, investments will not be confined by industrial, economic or geographical sector.

The Fund may also hold, on a temporary basis, all or part of its assets in cash or other ancillary liquid assets.

The Fund may utilise derivatives for the purposes of efficient portfolio management (typically hedging, including investing in hedged share classes, which attempts to mitigate against falls in the value of the Fund's assets and the effects of changes in currency exchange rates against the Fund's base currency, which is pounds sterling).

The Fund's benchmark is IA Mixed Investment 20-60% Shares. This represents a comparator benchmark because the Fund's performance can be compared to funds which also sit within this industry sector.
