All of the fund's expenses are charged to capital. This has had the effect of increasing the distributions paid on an annualised basis by approximately 0.90 percentage points on the B share class and reducing the capital performance by an equivalent amount.

Fund manager's commentary


The Federal Reserve shifted inflation-targeting from 2% to a 2% average over time, suggesting US inflation may overshoot without triggering monetary tightening. In response, global bonds fell 2.13% in sterling, the dollar fell 1.98% against the pound while gold equities and gold fell 3.33% and 2.33% respectively in sterling. Global equities rose 4.06% in sterling, with US equities outperforming, up 5.07%, fuelled by technology sector strength. Among the EF Brompton Global Income Fund's global holdings, Polar Capital Global Technology gained 6.26% but Fidelity Global Dividend gained only 0.46%. Equities in Asia excluding Japan lagged, rising 1.53% in sterling, but Schroder Oriental Income and Matthews Asia ex Japan Dividend outperformed, rising 6.56% and 3.67% respectively. UK equities also lagged, up 1.50%. Within the portfolio, Chelverton UK Equity Growth did best, up 5.59%, but Aberforth Split Level Income fell 5.60%. Equities in Europe excluding the UK, up 2.23% in sterling, were constrained by weak inflation data and a slowdown in economic recovery and BlackRock Continental European Income lagged, rising only 1.61%. UK inflation rose to 1.0% in July and UK government bonds and sterling corporate bonds fell 3.20% and 0.78% respectively. Among the bond investments, TwentyFour Dynamic Bond and Schroder Strategic Credit did best, returning 1.38% and 1.01% respectively, but the iShares \$ Treasury Bond 7-10 Years exchange-traded fund fell 3.01%. The EF Brompton Global Income Fund rose 1.70%† in August while the sector rose 1.33%. At 31 August, the historic yield was 2.98%††. Future income will be adversely affected by Covid-19-related dividend cuts.



Investment policy

The Fund will typically invest a minimum of 80% of its net asset value in collective investment schemes, exchange traded funds and unregulated collective investment schemes.

The Fund may also invest in investment trusts (and similar instruments), other transferable securities, money-market instruments, fixed income instruments, deposits and foreign exchange contracts.

It is expected that exposure to equity markets will typically range from a minimum of 20% to a maximum of 60% of the total Fund, with the aim of achieving the Fund's objective. However, investments will not be confined by industrial, economic or geographical sector.

The Fund may also hold, on a temporary basis, all or part of its assets in cash or other ancillary liquid assets.

The Fund may utilise derivatives for the purposes of efficient portfolio management (typically hedging, including investing in hedged share classes, which attempts to mitigate against falls in the value of the Fund's assets and the effects of changes in currency exchange rates against the Fund's base currency, which is pounds sterling).

The Fund's benchmark is IA Mixed Investment 20-60% Shares. This represents a comparator benchmark because the Fund's performance can be compared to funds which also sit within this industry sector.


