Fund manager's commentary


The Federal Reserve increased its 2021 economic growth forecast to 6.5% as recovery accelerated in the wake of Covid-19 vaccinations. President Biden enacted his \$1.9 trillion stimulus package and called for \$2.25 trillion of infrastructure spending funded by increased corporate taxes. US jobs data exceeded expectations, with unemployment falling to 6%. US stocks gained 5.77% in sterling, outperforming the 4.09% gain by global equities. Cyclical companies outperformed. Within the EF Brompton Global Income Fund, this contributed to 7.04% gain for the iShares World Value Factor exchange-traded fund but proved a headwind for growth-oriented managers. US technology shares lagged, up 2.60% in sterling, and Polar Capital Global Technology was even weaker, down 2.60%. UK stocks gained 4.12% and smaller stocks outperformed, up 5.08%. Among the portfolio's holdings, Aberforth Split Level Income, a small-cap specialist, gained 12.17% but Majedie Investments gained only 2.16%. In Asia excluding Japan, where equities fell 1.22% in sterling, Schroder Oriental Income rose 2.76% but Matthews Asia ex Japan Dividend fell 1.71%. Global bonds fell 0.62% in sterling as inflation expectations rose while UK government bonds rose 0.03% and sterling corporate bonds fell 0.17%. Within the portfolio, the sterling-hedged Legal & General Global Inflation Linked Bond holding and Fidelity Global Inflation-linked Bond returned 1.10% and 0.85% respectively but New Capital Wealthy Nations Bond fell 1.20%. The EF Brompton Global Income Fund gained 1.24%† in March while the sector rose 1.36%. At 31 March, the historic yield was 2.77%††. Investment policy

The Fund will typically invest a minimum of 80% of its net asset value in collective investment schemes, exchange traded funds and unregulated collective investment schemes.

The Fund may also invest in investment trusts (and similar instruments), other transferable securities, money-market instruments, fixed income instruments, deposits and foreign exchange contracts.

It is expected that exposure to equity markets will typically range from a minimum of 20% to a maximum of 60% of the total Fund, with the aim of achieving the Fund's objective. However, investments will not be confined by industrial, economic or geographical sector.

The Fund may also hold, on a temporary basis, all or part of its assets in cash or other ancillary liquid assets.

The Fund may utilise derivatives for the purposes of efficient portfolio management (typically hedging, including investing in hedged share classes, which attempts to mitigate against falls in the value of the Fund's assets and the effects of changes in currency exchange rates against the Fund's base currency, which is pounds sterling).
