All of the fund's expenses are charged to capital. This has had the effect of increasing the distributions paid on an annualised basis by approximately 0.90 percentage points on the B share class and reducing the capital performance by an equivalent amount.



Fund manager's commentary

Global equity markets gained 4.17% in sterling as investors became more sanguine about the Ukraine war as the two sides entered ceasefire talks. The Federal Reserve raised interest rates for the first time since 2018, taking them to 0.25%-0.5%, and forecast seven rate hikes in 2022. The Bank of England also hiked rates but its statement was less hawkish. Global bonds fell 1.20% in sterling as investors worried about inflation driven higher by rising energy costs. Within the EF Brompton Global Income Fund, Schroder Strategic Credit proved resilient, returning 0.26%. Longer-dated bonds were added through sterling-hedged holdings in the iShares \$ Treasury Bond 7-10 Years exchange-traded fund (ETF) and Vanguard Global Bond and Henderson Diversified Income as slowing economic growth may warrant a more defensive position. In the UK, where equities gained 2.05%, Aberforth Split Level Income UK Small Companies and Man GLG Income outperformed, up 7.45% and 2.15% respectively, but the iShares Core FTSE100 ETF gained only 1.50%. Yen weakness left Japanese equities up only 0.86% in sterling and Lindsell Train Japanese Equity did worse, down 3.55%. Among the portfolio's global equity holdings, BlackRock World Mining and Baillie Gifford Global Income Growth did best, up 6.28% and 5.39% respectively, but Polar Capital Global Technology lagged, up only 2.77%. Holdings in Blackrock Natural Resources Growth & Income and the Xtrackers MSCI World Health Care ETF were added. The EF Brompton Global Income Fund rose 2.16%† in March while the sector rose 1.52%. At 31 March, the historic yield was 2.75%++.





Investment policy

The Fund will typically invest a minimum of 80% of its net asset value in collective investment schemes, exchange traded funds and unregulated collective investment schemes.

The Fund may also invest in investment trusts (and similar instruments), other transferable securities, money-market instruments, fixed income instruments, deposits and foreign exchange contracts.

It is expected that exposure to equity markets will typically range from a minimum of 20% to a maximum of 60% of the total Fund, with the aim of achieving the Fund's objective. However, investments will not be confined by industrial, economic or geographical sector.

The Fund may also hold, on a temporary basis, all or part of its assets in cash or other ancillary liquid assets.

The Fund may utilise derivatives for the purposes of efficient portfolio management (typically hedging, including investing in hedged share classes, which attempts to mitigate against falls in the value of the Fund's assets and the effects of changes in currency exchange rates against the Fund's base currency, which is pounds sterling).

The Fund's benchmark is IA Mixed Investment 20-60% Shares. This represents a comparator benchmark because the Fund's performance can be compared to funds which also sit within this industry sector.
