All of the fund's expenses are charged to capital. This has had the effect of increasing the distributions paid on an annualised basis by approximately 0.90 percentage points on the B share class and reducing the capital performance by an equivalent amount.



Fund manager's commentary

Global equities fell 2.42% in sterling as rising Covid-19 infections caused lockdowns across Europe. Equities in Europe excluding the UK lagged, down 5.79% in sterling. Within the EF Brompton Global Income Fund, BlackRock Continental European Income did marginally better, falling 5.64%. In early November, the European Central Bank left policy unchanged but the Bank of England announced £150 billion of further quantitative easing and the government extended the furlough scheme. Four of the five UK equity holdings proved resilient as UK equities fell 5.06%. Majedie UK Income was weakest, down 5.37%, but two small company investments, Aberforth Split Level Income and Chelverton UK Equity Growth, rose 7.59% and 1.21% respectively, exceeding the 0.42% gain by smaller companies, while Majedie Investments gained 7.08%. Equities in Asia excluding Japan and emerging markets outperformed, up 2.79% and 2.06% respectively in sterling, and Chinese stocks, up 5.27%, did even better. Portfolio holdings lagged, however, with Schroder Oriental Income weakest, down 2.18%. Global bonds returned 0.08% in sterling. In the UK, government bonds fell 0.62% but sterling corporate and high-yield bonds outperformed, up 0.19% and 1.13% respectively. Within the portfolio, Henderson Fixed Interest Monthly Income returned 0.54% but the iShares \$ Treasury Bond 7-10 Years exchange-traded fund and New Capital Wealthy Nations Bond fell 1.31% and 0.04% respectively. The EF Brompton Global Income Fund fell 0.77%† in October while the sector fell 1.20%. At 31 October, the historic yield was 3.03%††. 



Investment policy

The Fund will typically invest a minimum of 80% of its net asset value in collective investment schemes, exchange traded funds and unregulated collective investment schemes.

The Fund may also invest in investment trusts (and similar instruments), other transferable securities, money-market instruments, fixed income instruments, deposits and foreign exchange contracts.

It is expected that exposure to equity markets will typically range from a minimum of 20% to a maximum of 60% of the total Fund, with the aim of achieving the Fund's objective. However, investments will not be confined by industrial, economic or geographical sector.

The Fund may also hold, on a temporary basis, all or part of its assets in cash or other ancillary liquid assets.

The Fund may utilise derivatives for the purposes of efficient portfolio management (typically hedging, including investing in hedged share classes, which attempts to mitigate against falls in the value of the Fund's assets and the effects of changes in currency exchange rates against the Fund's base currency, which is pounds sterling).

The Fund's benchmark is IA Mixed Investment 20-60% Shares. This represents a comparator benchmark because the Fund's performance can be compared to funds which also sit within this industry sector.
