All of the fund's expenses are charged to capital. This has had the effect of increasing the distributions paid on an annualised basis by approximately 0.90 percentage points on the B share class and reducing the capital performance by an equivalent amount.

### Fund manager's commentary

The Federal Reserve and Bank of England left their official interest rates unchanged with US inflation higher than expected but the European Central Bank cut its rate by a quarter percentage point shortly after the month end because eurozone inflation prospects had improved. Equities in Europe excluding the UK outperformed, rising 3.73% in sterling against 2.40% for global equities. The EF Brompton Global Income Fund's lack of an allocation to Continental European equities hurt performance and its sole holding, BlackRock Continental European Income, rose only 2.45%. US stocks also outperformed, rising 3.22% in sterling, with technology stocks particularly strong, rising 7.20% following results from Nvidia, the artificial intelligence microchip designer. Within the portfolio, Polar Capital Global Technology rose 4.98%. Stocks in the UK, where voters head to the polls shortly, gained 2.43%, with small stocks doing best, up 6.23%, aided by takeover activity showing value in the sector. Within the portfolio, Aberforth Split Level Income gained 9.49% but Artemis Income gained only 1.85%. Japanese stocks lagged, falling 0.38% in sterling partly because of yen weakness, and JP Morgan Japan Small Cap Growth & Income did worse, falling 2.65%. Global bonds fell 0.36% in sterling but UK government bonds and sterling corporate bonds rose 0.78% and 0.91% respectively. Within the portfolio, TwentyFour Dynamic Bond did best, rising 1.44%, but the iShares \$ Treasury Bond 7-10 exchange-traded fund fell 1.91%. The EF Brompton Global Income Fund rose 1.06%† in May while the sector rose 0.85%. At 31 May, the historic yield was





#### **Investment policy**

The Fund will typically invest a minimum of 80% of its net asset value in collective investment schemes, exchange traded funds and unregulated collective investment schemes.

The Fund may also invest in investment trusts (and similar instruments), other transferable securities, money-market instruments, fixed income instruments, deposits and foreign exchange contracts.

It is expected that exposure to equity markets will typically range from a minimum of 20% to a maximum of 60% of the total Fund, with the aim of achieving the Fund's objective. However, investments will not be confined by industrial, economic or geographical sector.

The Fund may also hold, on a temporary basis, all or part of its assets in cash or other ancillary liquid assets.

The Fund may utilise derivatives for the purposes of efficient portfolio management (typically hedging, including investing in hedged share classes, which attempts to mitigate against falls in the value of the Fund's assets and the effects of changes in currency exchange rates against the Fund's base currency, which is pounds sterling).

The Fund's benchmark is IA Mixed Investment 20-60% Shares. This represents a comparator benchmark because the Fund's performance can be compared to funds which also sit within this industry sector.


