Fund manager's commentary

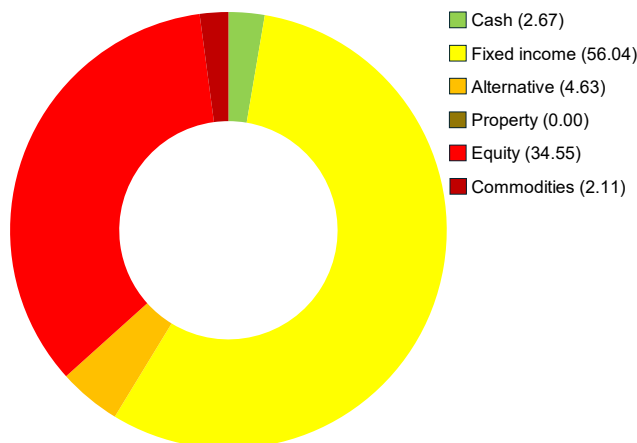
The US Treasury announced increased liquidity support for the bond market. Purchases of longer-dated US government bonds will at least double to curb yields and the cost of funding public sector debt. US inflation rose to 3.4% in July according to the latest data because the Iran War has increased the oil price, up 2.15% in sterling in August. Global bonds fell 0.29% in sterling as the dollar fell 0.74% against the pound. Within the WAY Global Cautious Portfolio, the Legal & General Global Inflation Linked Bond holding and Schroder Strategic Credit returned 0.58% and 0.49% respectively but the iShares \$ Treasury Bond 0-1 Year exchange-traded fund fell 0.45%. Geopolitical uncertainty fuelled bullion prices and the iShares Physical Gold exchange-traded commodity holding, which was increased, rose 12.46%. Stronger gold prices also contributed to 1.78% gain for Trojan, which has a significant gold allocation. Technology stocks gained 4.17% in sterling, outperforming the 1.93% rise for global equities. Polar Capital Global Technology, which has big holdings in semiconductors and other hardware, gained 3.54%. Japanese stocks rose 2.78% in sterling and Lazard Japanese Strategic Equity and Man Japan CoreAlpha outperformed, rising 4.33% and 3.02% respectively. In emerging markets and Asia excluding Japan, where equities gained 2.63% and 2.54% respectively in sterling, Man Asia (ex Japan) Equity rose 4.57% but Pacific North of South Global Emerging Markets Equity fell 0.59%. Atlas Global Infrastructure was added to the global equity allocation. The WAY Global Cautious Portfolio rose 1.12% in August while the sector rose 0.93%.

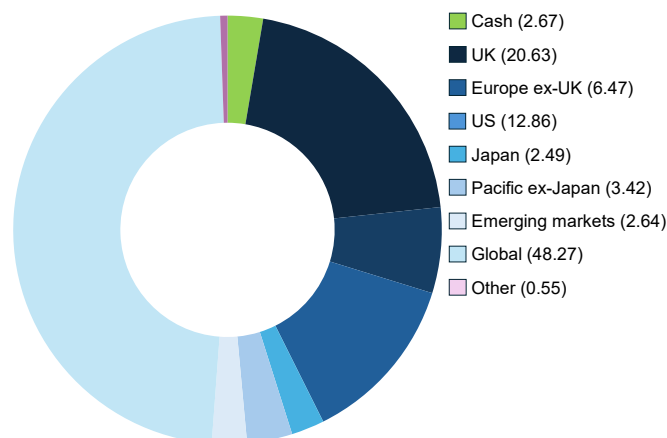

Investment objective & policy

The objective of the Fund is to provide capital growth, net of all fees, over the longer term (5 years), by utilising a cautious approach to investing. Capital invested in the Fund is at risk and there is no guarantee that the investment objective will be met.

The Fund will seek to achieve its objective through conservative investment in an actively managed and diversified portfolio of collective investment schemes, investment trusts, other listed securities, cash or near cash, deposits and money market instruments. The Fund will typically invest up to 35% of its portfolio in equity securities. The Fund may invest up to 20% in unregulated collective investment schemes.

There will be no restrictions on the underlying content of the investments held, in terms of investment type, geographical or economic sector.

Derivatives will not be used. Currency hedging transactions, including investing in hedged share classes, may be used where appropriate, in order to mitigate against the effects of changes in currency exchange rates against the Fund's base currency which is pounds sterling. Borrowing of up to 10% of the Fund's net asset value will be permitted.

The Fund's benchmark is IA Mixed Investment 0-35% Shares. This represents a comparator benchmark because the Fund's performance can be compared to funds which also sit within this industry sector.
