Investment Objective and Investment Policy

Objective:
The investment objective of the Fund is to provide long-term capital growth, i.e., over a period of at least 5 years.

Policy:
The Fund will seek to achieve its objective from an actively managed and diversified portfolio of collective investment schemes, including investment trusts.

The Fund will have exposure to cash, fixed interest securities, equity, and equity-linked investments selected from various markets worldwide, encompassing a variety of economic sectors.

The Fund will typically invest between 20% and 60% of its portfolio in schemes which invest in equity securities.

The use of derivatives is not permitted, but borrowing of up to 10% of the Fund's net asset value will be permitted on a temporary basis. The Fund may invest in hedged share classes of underlying funds.

The Fund may hold up to 10% of its net asset value in cash or near cash where this is considered reasonable in achieving the objective of the Fund.

Borrowing of up to 10% of the Fund's net asset value will be permitted on a temporary basis. The Fund may invest in hedged share classes of underlying funds.

Benchmark:
The appropriate comparator benchmark against which the performance of the Fund can be measured is the Investment Association's IA Mixed Investment 20-60% Shares sector.

Other information:

- Investment in the Fund should be regarded as long-term, which is at least 5 years.
- There can be no guarantee that the objective of the Fund will be achieved.
- Upon redemption, particularly in the short-term, you may receive less than the original amount invested.
- In relation to share classes where there is an Entry Charge (see overleaf), the charge is deducted from your investment at the outset. Therefore, an equivalent rise in the value of shares is required before the original investment can be recovered. Various other charges accrue daily, therefore an equivalent rise in the value of units is required before the original investment can be recovered.
- As you hold accumulation units, income from investments in the Fund will be rolled up into the value of your units.
- Due to the investment objective of the Fund, it is likely that any return generated will be in the form of capital appreciation.
- You can buy and sell your units in the Fund on each business day between 9am and 5pm.

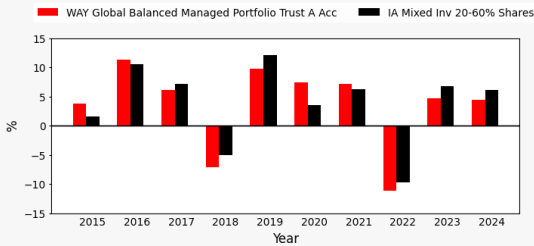
The entry and exit charges shown are maximum figures. In some cases (including when switching to other funds) you might pay less - you can find out actual entry and exit charges from your financial adviser.

The ongoing charges are taken from income. Should income levels be insufficient, investments in the Fund may be sold to cover the Fund's expenses, its capital assets may be used to meet ongoing charges, and the value of your units would be reduced.
