Fund manager's commentary

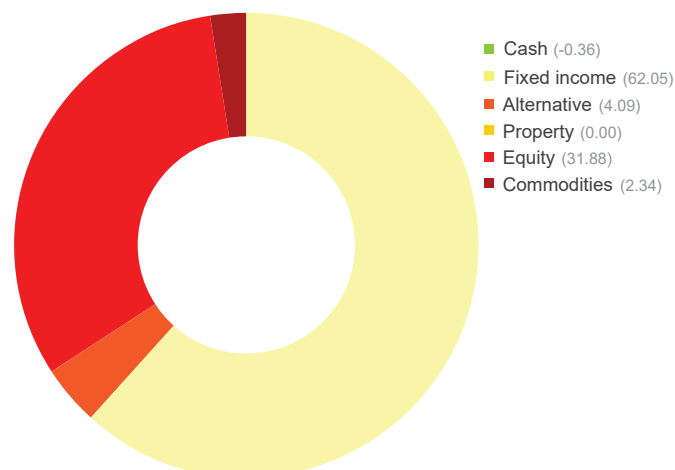
Global equities and global bonds gained 4.11% and 3.43% respectively in sterling in response to easing inflation, with US, euro-zone and UK headline measures dropping to 3.1%, 2.4% and 3.9% respectively, partly due to lower oil prices. Federal Reserve surveys showed investors thought interest rates had peaked and would fall as soon as June. Within the WAY Global Cautious Portfolio, the sterling-hedged iShares \$ Treasury Bond 7-10 Years exchange-traded fund (ETF) and Vanguard Global Bond holdings rose 3.80% and 3.35% respectively. In the UK, government bonds, investment-grade corporate bonds and high-yield bonds returned 5.72%, 4.63% and 2.82% respectively. Janus Henderson Strategic Bond rose 5.51%. Interest-rate sensitivity increased through reductions in cash and Schroder Strategic Credit in favour of increases in TwentyFour Strategic Income and Jupiter Dynamic Bond and an increased equity allocation. UK equities outperformed, rising 4.50%, with small companies particularly strong, up 9.63%. Both significant UK equity holdings outperformed, with Liontrust Special Situations strongest, up 7.36%. Within the global equity allocation, Polar Capital Global Technology rose 4.84%. Dimensional Global Targeted Value was increased and Polar Capital Global Insurance reduced. Equities in Asia excluding Japan and emerging markets lagged, up 2.83% and 3.22% respectively in sterling. Redwheel Global Emerging Markets, up 0.60%, did worse. Among alternative holdings, CT Real Estate Equity Market Neutral rose 0.27% but Man GLG Asia Pacific (ex-Japan) Equity Alternative fell 0.06%. Trojan, a conservative multi-asset investment, was reduced. The WAY Global Cautious Portfolio rose 3.54%† in December while the sector rose 3.52%. 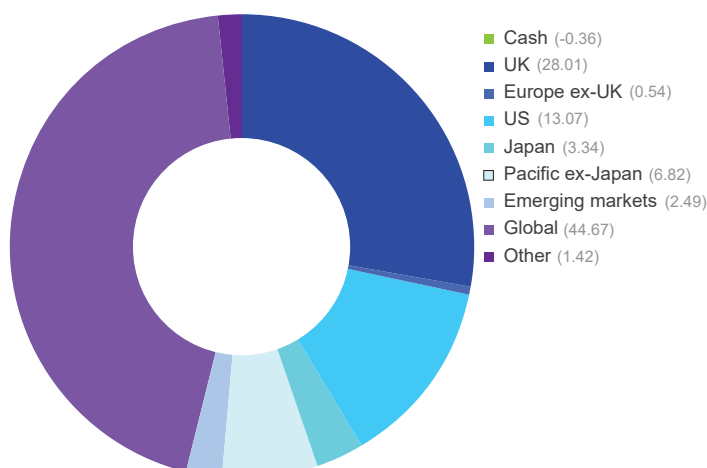

Investment objective & policy

The objective of the Fund is total investment return against the IA Mixed Investment 0-35% Shares sector over a 3 year rolling period. Capital invested in the Fund is at risk and there is no guarantee that the investment objective will be met over the 3 year rolling period or in respect of any other period.

The Fund will seek to achieve its objective through conservative investment in an actively managed and diversified portfolio of collective investment schemes, investment trusts, other listed securities, cash or near cash, deposits and money market instruments. The Fund will typically invest up to 35% of its portfolio in equity securities. The Fund may invest up to 20% in unregulated collective investment schemes.

There will be no restrictions on the underlying content of the investments held, in terms of investment type, geographical or economic sector.

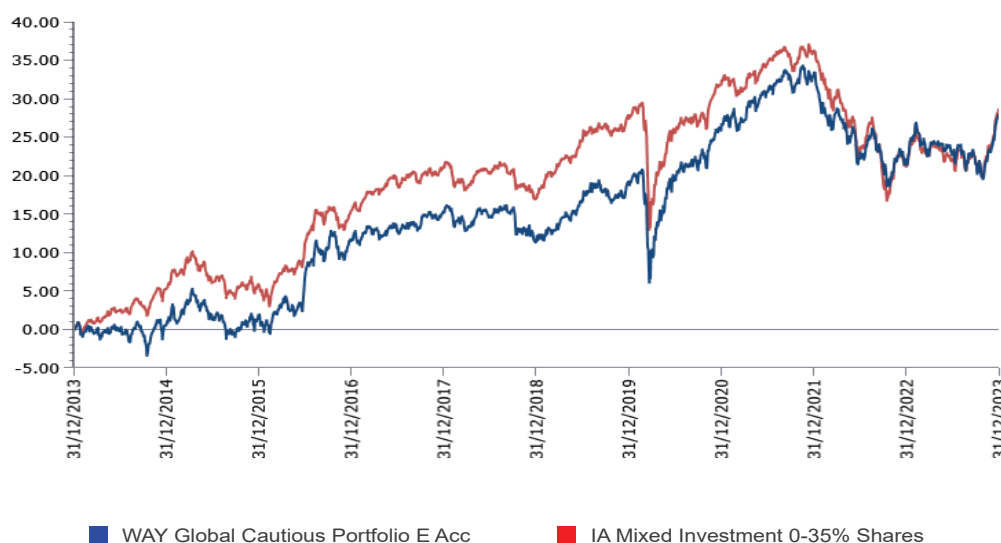
Derivatives will not be used. Currency hedging transactions, including investing in hedged share classes, may be used where appropriate, in order to mitigate against the effects of changes in currency exchange rates against the Fund's base currency which is pounds sterling. Borrowing of up to 10% of the Fund's net asset value will be permitted.

The Fund's benchmark is IA Mixed Investment 0-35% Shares. This represents a comparator benchmark because the Fund's performance can be compared to funds which also sit within this industry sector.
