<p>*valid from 28th October 2024</p> <p>Objective: The objective of the Fund is to provide capital growth, net of all fees, over the longer term (5 years), by utilising a cautious approach to investing. Capital invested in the Fund is at risk and there is no guarantee that the investment objective will be met.</p> <p>Policy: The Fund will seek to achieve its objective through conservative investment in an actively managed and diversified portfolio of collective investment schemes, investment trusts, other listed securities, cash or near cash, deposits and money market instruments.</p> <p>The Fund will typically invest up to 35% of its portfolio in equity securities.</p> <p>The Fund may invest up to 20% in unregulated collective investment schemes.</p> <p>There will be no restrictions on the underlying content of the investments held, in terms of investment type, geographical or economic sector.</p> <p>Derivatives will not be used. 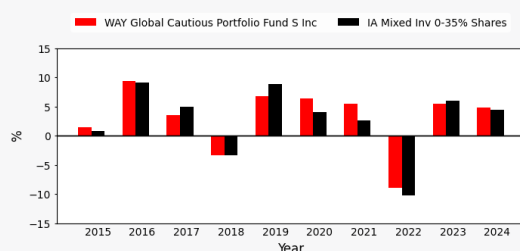
