

Fund manager's commentary



Managers Index for manufacturing fell below 50, signalling contraction ahead. All of the WAY Global Growth Portfolio's significant Asia ex-Japan and emerging markets equity holdings were relatively resilient. In India, where equities fell 0.34% in sterling, Stewart Investors Indian Subcontinent did best, rising 0.39%, while Man GLG Asia (ex Japan) Equity and Redwheel Global Emerging Markets were weakest, down 4.39% and 4.16% respectively. UK inflation eased from 7.9% in July to 6.8% but core inflation was unchanged at 6.9%. UK stocks underperformed, falling 2.52% while small companies fell 2.57%. Liontrust Special Situations was most resilient, down 1.56%, but the small-company specialists, Chelverton UK Equity Growth and Liontrust UK Smaller Companies, underperformed, down 3.55% and 3.43% respectively. In Europe excluding the UK, where stocks fell 2.46% in sterling, Janus Henderson European Smaller Companies lagged, down 4.69%. UK government bonds and sterling corporate bonds fell 0.60% and 0.12% respectively. Within the portfolio, Schroder Strategic Credit returned 0.25% but the sterling-hedged holding in Redwheel Asia Convertibles and Janus Henderson Strategic Bond fell 2.43% and 0.73% respectively. With gold down 0.19% in sterling, the iShares Gold Producers exchange-traded fund fell 4.48%. The WAY Global Growth Portfolio fell 1.63%† in August while the sector fell 1.26%.

Global equities fell 1.26% in sterling while global bonds gained 0.15%. Equities in Asia excluding Japan and emerging markets, lagged, falling 4.95% and 4.69% respectively in sterling, driven lower by Chinese stocks, down 7.55% as China's Purchasing

Investment objective & policy

The objective of the Fund is to seek a high level of capital growth over a period of at least 5 years.

The Fund will seek to achieve its objective from an actively managed portfolio of collective investment schemes, investment trusts, other transferable securities, cash or near cash, deposits and money market instruments. The Fund will typically invest between 40% and 85% of its portfolio in equity securities.

There will be no restrictions on the underlying content of the investments held, in terms of investment type, geographical or economic sector.

The use of derivatives and/or hedging transactions will be permitted in connection with the efficient portfolio management of the Fund (typically hedging, which attempts to mitigate against falls in the value of the Fund's assets and the effects of changes in currency exchange rates against the Fund's base currency, which is pounds sterling). Borrowing of up to 10% of the Fund's net asset value will be permitted.

On giving 60 days notice to Shareholders, the Fund may, in addition to its other investment powers, use derivatives and forward transactions for investment purposes. It is not intended that the use of derivatives in this way will change the risk profile of the Fund.

Subject to the above, the Fund may invest in any asset class and adopt any investment technique or strategy permitted under the rules in COLL as such rules are applied to Non-UCITS retail schemes.

The Fund's benchmark is IA Mixed investment 40-85% shares. This represents a comparator benchmark because the Fund's performance can be compared to funds which also sit within this industry sector.


