# **USER NOTICE**

#### Terms of use

This notice sets out the terms on which users may access the Brompton Asset Management portal (portal). Clients and their advisers and representatives may, via the portal, view the assets and investments managed on clients' behalf by Brompton Asset Management and for which Multrees provides safe custody.

## Definitions

**Brompton** is Brompton Asset Management Limited, a company registered in England, company number 06866020, with registered office at 1 Knightsbridge Green, London, SW1X 7QA.

**Multrees** is Multrees Investor Services Limited, is a company registered in England, company number 07225386 with registered office at One Carter Lane, London EC4V 5AN.

Both are authorised and regulated by the Financial Conduct Authority.

**Client** is "you" or "your" if Brompton provides you with discretionary investment management services.

Advisers and representatives are people whom clients have authorised to have access via the portal to information about them and their investments.

Portal is the Brompton Asset Management portal whether accessed via a web browser or App.

User or users refer to clients, advisers and representatives that have access to the portal.

<u>This notice applies to all access to the portal</u>. Please read it before using the portal. By using the Portal, you accept the terms set out in this notice and agree to abide by them. If you do not agree to these terms, please refrain from using the portal.

#### Accessing the portal

Users may only use the portal to view their own information or another person's information if that person has given permission for them to do so. If users do not have permission, they must not access that information.

If you have given permission to an adviser or representative to access your information, it is your responsibility to tell Brompton if you no longer wish this person to have access. Brompton and Multrees have no liability for the actions of any adviser or representative in relation to their use of the portal.



# Each person accessing the portal must have their own log-in ID and password. Users are responsible for maintaining the confidentiality of their passwords and any other access credentials used to access the portal and this information must not be disclosed to others. Brompton will have no liability for the actions of other people in relation to their use of the portal if users have shared their log-in details with them.

## **Portal information**

The value of investments is calculated using the closing prices from the previous working day. If, therefore, you access the portal on a Saturday, Sunday or Monday, the valuation will be based on Friday's closing prices.

The cash in an account may reflect an investment transaction still in progress. For example, sale proceeds might have been received but any corresponding purchases may not have been made. Please, therefore, check the value of any investments or cash balances with your investment manager before providing Brompton with any instructions such as requests to withdraw money. In general, it is always advisable to check with Brompton before making financial decisions based on information displayed within the Portal.
